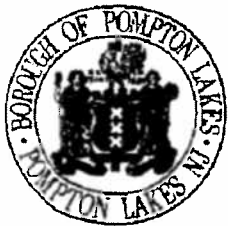

Equipment to be carried on all trucks should include:

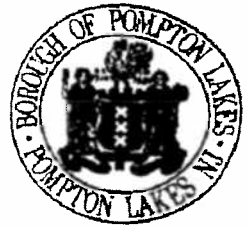
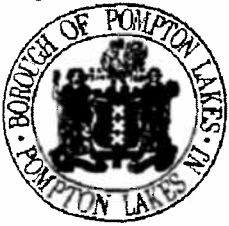
- Rotating or flashing amber lights (with required permit).

- High visibility safety vest for each employee on crash scene.
- Shovel/Broom.
- Two way communications (radio or cellular).
- Name of Company and Town affixed to each side (no magnets) 3" high lettering minimum.
- Price/Approval card will be displayed in rear window of tow/flat bed truck.
